

CHAPTER MINUTES

The Col, Upton Hayes Chapter #235, Missouri Society, Military Order of the Stars and Bars, held it's Quarterly Meeting (postponed from January due to inclement weather) on Friday 18 February 2011 at the Heritage Cafeteria, 1364 E. Battlefield, Springfield, Missouri, with 3 Members and 7 Guests present.

- 1. Commander Les Wood called the Meeting to Order.
- 2. Adjutant Perry reported that the Chapter has 10 Members and has Funds in the amount of \$391.16. A Deposit was made on 18 November 2010 of \$45.00 for Dues received from Bob Caudle. An expenditure was made on 29 December 2010 of \$11.31 for production of THE HAYES REPORT.
- 3. Plans were discussed for a field trip to Lexington, Missouri, on Saturday 14 May 2011. The itinerary will include a carvan to Higginsville, Missouri, to the Confederate Memorial State Historic Site, then to Dover, Missouri, and the gravesite of John Newman Edwards, then to Waverly, Missouri, and the Shelby Monument, then to Lexington, Missouri, to the Lexington State Historic Site with a possible tour of the Anderson house and downtown Lexington and Machpelah Cemetery, then to Richmond, Missouri, and the gravesite of "Bloody Bill" Anderson, the Monument to Col. Alexander Doniphan, and the gravesite of Bob and Charlie Ford, then to Orrick, Missouri, and the site and Monument where Bill Anderson was killed, then back to Springfield. The tour is open to all MOS&B, SCV, UDC Members and their families and Guests. We will caravan, so vehicles will be needed. All going on the tour are responsible for their own expenses. The tour will begin from Waffle House on North Kansas Expressway at I-44 at 6:00 a.m. for breakfast. This will be an all-day trip.
- 4. Chapter elections were held with the following results: Commander -- Les Wood; Lt. Commander -- Jason R. Perry; Adjutant -- Rick Perry.
- 5. No discussion was held on the Chapter's proposed Confederate Monument Book. Adjutant Perry passed around a copy of a "Civil War" Monument book recently produced by the Daughter of Union Veterans which covers a 24 County area in Southwest Missouri and is predominently Union oriented, but does include most of the Confederate Monuments in this area.

**** FIELD TRIP ****

The Col. Upton Hayes Chapter #235 MOS&B has planned a Field Trip to the area of Lexington, Missouri. There is no explicit purpose for the trip other than to take in certain Missouri Confederate sites in the area. The trip will consist of a caravan tour, so depending on how many plan to join us, vehicles will be needed. All participants are responsible for their own expenses which will include food, drinks, fuel, and a fee at Lexington for touring the Anderson House. All SCV, MOS&B, and UDC Members along with their families and Guests are welcome. Hopefully we will have enough participants to carpool so we can enjoy good comaraderie and conversation between sites. Our itenerary will be as follows: We will assemble at Waffle House on North Kansas Expressway near I-44 in Springfield at 6:00 a.m. and have breakfast. If you do not desire to have breakfast, meet us at Waffle House at 7:00 a.m. We will proceed to the Confederate Memorial State Historic Site at Higginsville and tour the Cemetery and Chapel. We will then proceed to Dover and visit the gravesite of John Newman Edwards. From Dover we will go to Waverly and see the Monument to Gen. Jo O. Shelby, which was unveiled in 2009. We will then proceed to Lexington and tour the visitors' center at the State Historic Site, and also the Anderson House and downtown Lexington including Machpellah Cemetery. From Lexington we will cross the Missouri River to Richmond to the gravesite of Capt. William T. Anderson, known as "Bloody Bill", then to the Square where there is a statue of Col. Alexander Doniphan in front of the Court House, and the Cemetery where Bob Ford is buried. We then travel West to Orrick to the site where "Bloody Mill Bill" was killed. Then back to Springfield. The date decided upon for this trip is Saturday 21 May 2011 (PLEASE NOTE DATE CHANGE). Hope everyone can join us. The more the merrier.
