## North Carolina Honors Lee's Birthday

RALEIGH, NC – There was very little standing room available January 19, 1999, in the historic House Chambers of the NC State Capitol. Those that were lucky to get inside were whisked back into time to see and hear Mildred Lee, daughter of Gen. Robert E. Lee. Mildred, portrayed by Nora Brooks of Charlotte, gave a first person presentation of the life of her papa to over 175 people.

This 10th Annual Robert E. Lee Birthday Celebration was sponsored by the Capt. James I. Waddell MOS&B Chapter, Raleigh, and the Capt. Samuel A. Ashe Chapter 2572 UDC, Raleigh. Reilly's Battery delivered a two-gun night artillery salute to Gen. Lee on the Capitol grounds following the ceremony.

### Nine Honorary Commander-General's Named At St. Louis

ST. LOUIS – In resuming a past tradition, the national MOS&B Awards Committee nominated and Commander-General Troy Massey approved, one of the most prestigious awards of the MOS&B: the title of Honorary Commander-General. This titling is the only award which is specified by name in the national MOS&B Constitution. This year's recipients were nominated based upon their years of devoted service to the preservation of Confederate heritage and their lengthy service in remembering the Confederate Officer Corps.

#### Daniel W. Jones Commander Army of Northern Virginia Dept.

Dan was born in Raleigh, NC, and has lived in the same area for most of his life. He currently resides in Cary, is married, and is the father of a son (deceased) and a daughter.

He has a year-old grandson.

Dan received his B.S. and M.A. from East Carolina University and has completed additional studies at NC State University and UNC-CH. His masters was in School Administration with a concentration in Social Studies and English.

During the Korean War, Dan served in the US Air Force as a historian. His service tenure was followed by appointment as Superintendent of North Carolina's Fort Macon State Park. Later Dan became a school principal and subsequently was employed by the NC State Department of Public Instruction. He retired as a senior executive with thirty-five years in his education career. In his position, he lobbied the NC Legislature for the state education budget.

Dan is a Methodist and has served as the Chairman of the Board of Trustees of his church. He is a Mason, Shriner (served as Commander of the Legion of Honor), and is a member of the American Legion. He was a founder and first President of the Cary Jaycees, and was originator and has served as President of the then 35,000 member State Employees Association.

Dan is a member of the Raleigh Chapter of the SAR, the 6th Regiment NC StateTroops Camp 106 SCV, Apex, and is the current Commander of the Capt. James I. Waddell Chapter MOS&B, Raleigh. Dan is the MOS&B Historian General and is serving as Commander of the ANV Dept. of the Order.



## **Evetts Haley, Jr.** Chief of Protocol

Evetts Haley, Jr. was born in Austin, TX, in 1931, and is a fifth generation cattle raiser. He and his wife, Frances, are the parents of two sons and two daughters. Evetts is descended from James Evetts, a hero of the Battle of San Jacinto and is an active member of the Sons of the Republic of Texas. He is also a member of the Texas & Southwestern Cattle Raisers' Association, the National Cattlemen's Association, SAR, SCV, and the Order of the Southern Cross of which he is a past Commander-in-Chief. Evetts was a founder and first Commander of the Dunn-Holt-Midkiff SCV Camp 1441, Midland, TX. He is a past Commander of the Texas Society MOS&B and the Trans Mississippi Dept. MOS&B.

Evetts is Chairman of the Board of Trustees of the Nita Stewart Haley Memorial Library and J. Evetts Haley History Center in Midland which is a privately endowed non-tax supported, independent institution dedicated to the preservation of the history of Texas and the Southwest. Other than a brief hitch as a research analyst in Dallas and one as editor of the *Arkansas Farmer Magazine* at Little Rock, he has been a free-lance writer for many years and has ranched all his life. Evetts is presently Chief Aide-de-Camp of the SCV.

Collin is a graduate of Southampton Academy and has a B.B.A. degree from the College of William & Mary. He is a manager of a retail furniture store. He and his wife Judy have been
